A user registration to Crosskey Banking Solutions Ab Ltd's Open Banking Market and using S-Bank Sandbox does not constitute any right to access to piloting with real customer data without S-Bank's prior express consent.

Registered users may test and evaluate functionalities and features of their payment applications by using test data and data field structures provided by S-Bank.

By submitting and confirming your email address in the sign-up process, you approve that S-Bank may send Sandbox related emails to that address.

By using the Sandbox, you acknowledge and agree that:

- The information that you provide to S-Bank is accurate,
- S-Bank may suspend or terminate your right to access or use of the Sandbox in case of violation of the Terms of use,
- S-Bank provides information and other materials in the Sandbox on "as is" basis, without any warranty of any kind, whether express or implied, including without limitation the implied warranties of merchantability, fitness for a particular purpose and non-infringement of third party rights, and the use of the Sandbox is at the user's own initiative and risk,
- Any information or functionalities provided in the Sandbox may be subject to changes and do not constitute a binding commitment to implement services or specific technical or functional details to the services,
